The position is part of the ERC-funded consolidator project <u>TibSchol</u> - "The Dawn of Tibetan Buddhist Scholasticism (11th– 13thc.)" (H2020-CoG-101001002), which aims at a wide-ranging exploration of the formative phase of the Tibetan Buddhist scholastic tradition.

Your tasks:

- Contribute to the sub-projects "Persons, schools, and networks in early Tibetan scholasticism" and "Early Tibetan scholastic literature: the corpus, its constitution and diffusion." This involves the investigation of historical sources and data mining from a large corpus of early scholastic works in manuscript format
- Integrate the collected data into the project's database
- Publish research results at the highest scientific level
- Present research findings at international conferences
- Support the organization of academic events and activities related to the project

Your profile:

- Completed PhD in Buddhist Studies or Tibetan Studies
- Demonstrated academic excellence (incl. peer-reviewed publications in international journals)
- Excellent knowledge of classical Tibetan is mandatory; knowledge of other languages relevant to the broader Buddhist scholastic landscape is desirable
- Experience in textual studies (in particular with manuscripts in cursive script) as well as research involving Tibetan historical sources and scholastic literature (demonstrated in publications and/or MA/PhD thesis)
- Deep familiarity with the early Tibetan scholastic context and relevant textual corpus, as well as with related secondary literature and current research in the field
- Excellent command of English (written and spoken) and strong inter-personal skills
- Capacity to carry out research independently and as part of a team
